



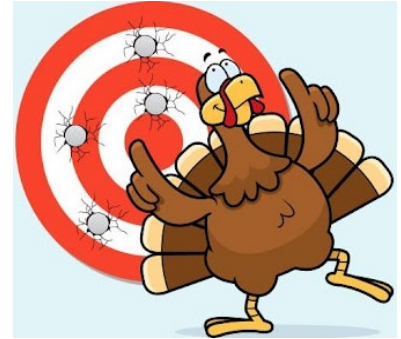

THANKSGIVING “BIG TURKEY” SHOOT FOR CUB SCOUTS

9am-3:30pm, Saturday, November 21 @ Camp Tamarancho

Presented by your Marin Council Range & Target Activities Volunteers!

All Marin Council Cub Scouts are invited to this exciting event to build their marksmanship skills on the Archery and BB-gun ranges. This activity is for Cub Scouts only; Tigers through Webelos (*Lions are not permitted to shoot per BSA Policy, and Tigers must have an adult partner with them at all times*).



The cost per participant is just \$10.00 and includes 1 range session each at Archery and BB-gun, plus SlingShot open shoot, and a fun participation patch!

But don't worry, NO turkeys will be shot!

Reserve your fun day at the ranges through our online registration portal shown on the Marin Council website homepage at www.boyscouts-marin.org. The registration deadline is November 19, but don't delay because space is limited to just 8 Scouts per session on each range! **NO WALK-INS ARE ALLOWED!**

A Marin Council Cub Scout Shooting Sports Authorization form must be completed and signed by at least one custodial parent/guardian for each Cub Scout participant in order to shoot – ***no exceptions (see form attached)***.

Sessions are 40 minutes long starting at 9:00am and finishing by 3:30pm. All participants must arrive in camp at least 15-20 minutes before their session for parking, registration check-in, walking to the ranges, and a mandatory safety briefing. If they miss their start time, they will not be allowed to shoot!

No loose clothing or jewelry can be worn while shooting on the range. Everyone must wear closed-toed shoes in camp. No dogs or other pets are allowed (*except service/helper dogs*) on the property due to wildlife concerns.
