

# Marin Council Boy Scouts of America CAMPERSHIP APPLICATION

Use this form to apply for camperships for Cub Scout day camp, Tiger camp, Adventure Weekend, Webelos Woods, Boy Scout resident camp, NYLT, and National high adventure base camps.

The Marin Council, Boy Scouts of America, provides camperships for Scouts from the Marin Council in order to attend Marin Council camping programs as well as a limited number of scholarships to National High Adventure Bases. Camperships are not available from the Marin Council to Scouts from other councils and are not available for Marin Scouts attending camping programs in other councils.

Our camperships are made available thanks to the generosity of key donors as well as from general operating funds supported by Friends of Scouting contributions from throughout the council. Those wishing to contribute in support of camperships should contact the Marin Council Scout Executive at 415-454-1081.

Instructions for parents/guardians to apply for camperships:

- Campership applications are *not* registration forms for camp, they are applications for financial assistance. You must also complete the appropriate registration form for the camp your Scout is attending; indicate on your registration that you are applying for a campership. If your son is attending Boy Scout Summer Camp with his troop, notify your troop leader that you are applying for a campership and follow the signup procedures for your troop.
- Use only one campership form per Scout and one form for each camping activity for which you are applying. If applying for a sibling campership, a separate form needs to be completed for each Scout sibling.

- Campership applications should be submitted to the Marin Council office prior to May 15. Camperships can be submitted well in advance of that deadline.
- Complete the first two pages of the campership application. If you are applying for a campership to a National high adventure base, the Scout's unit leader will need to complete the last page in order for consideration to be given.
- Campership will not exceed 50% of camp fees except for extreme hardship. Partial payment for camp programs should be submitted with your camp registration. You will be notified of your remaining balance after your Scout's campership application is reviewed by the council.
- Scouts are expected to help pay their own way. Your application should demonstrate how your Scout participates in his unit's fundraising as well as any jobs or chores he has taken on to help pay for camp.
- Inquiries regarding payment plans which might help lessen a campership requirement should be made to the Marin Council office.
- Contact us with any questions. We are here to help your Scout attend camp.
