

Dear Prospective Applicant,

Thank you for your interest in a seasonal Camp Staff position at Marin-Sierra. The Marin Council, Scouting America invites you to apply for an exceptional Summer job opportunity with the promise of great adventure during our 76th year of operation in scenic Emigrant Gap, California!

Staffing a Resident Camp can be one of the most challenging and rewarding experiences you will ever have. We say "rewarding" because staff members build life-long friendships, develop better personal habits, experience working together in teams, learn new skills and much more! The word "challenging" is often used as well because while staffing a busy camp is certainly fun, it is also hard work. Most people don't realize the energy and dedication expended to make Camp Marin-Sierra such a wonderful place for all who attend. It has been said by experienced staffers, "if you are NOT looking for a few weeks of hard work outdoors, then you should probably find something else to do for the Summer!"

However, for those Camp Staff alumni who return year after year, the rewards far outweigh the challenges. Those challenges only make our character stronger and of more value as adult citizens in our community.

Here's how the application process works:

- 1) Fill out the application form and send it to us as soon as possible; directions are found on the cover page. Although there is no application deadline, most people apply before the end of the year. Applying early may give you a better chance of being hired or getting the position you desire. However, if you are reading this after the first of the year, go ahead and apply! Often there are many positions still available. On the forms, be sure to use an email address that you check frequently because we communicate largely by email.
- 2) You will likely not hear from us until after the new year. Interviews begin in early February and continue into late March primarily via ZOOM.
- 3) Assuming you are interviewed during the first couple months of the new year, sometime around the middle of March you will receive a letter stating if you are hired. Next, you will receive a hiring packet in early April by US mail and follow-up email with all of your paperwork including a contract and pay rate, seasonal job description, numerous forms and important information.

APPLICANT CONSIDERATIONS:

ALL POSITIONS require Scouting America membership registration through the Marin Council, with Criminal Background Checks (CBC) and LiveScan fingerprinting for all adults (18 years or older), or a School Work Permit requirement for all ungraduated minors residing in the state of California.

MOST POSITIONS, except for Counselor-in-Training (C-i-T) volunteers, are hired for the entire FIVE-week season. Rarely do we hire for partial-Summer terms, although we do make exceptions. Thank you for your understanding.

- *In select cases such as BSA National Camping School (NCS) attendance, the Marin Council will pay for participant registration fees or provide the necessary training sessions locally.
- **Specialized training sessions may include various NRA Basic Shooting, USA Archery, Restaurant ServSafe, or Emergency Medical Response-related certifications.
- ***All Waterfront Staff must have the American Red Cross Lifeguard certification, as well as the enhanced level of CPR/AED training for the Professional Rescuer.
- ****Counselor-in-Training (C-i-T) positions do not require any special training and are scheduled for a 2, 3 or 4-week volunteer assignment/commitment at the discretion of the Camp Director for experience in a variety of program or operational areas.
