



Campership Application

(Camp Fee Financial Aid)

Thanks to the generosity of key donors as well as from general operating funds supported by Friends of Scouting, the Marin Council provides camperships for Scouts from the Marin Council in order to attend Marin Council camping programs as well as a limited number of scholarships to National High Adventure Bases.

Instructions for parents/guardians to apply for camperships:

- Camperships are not available for non-Marin Scouts nor for Marin Scouts attending camping programs in other councils.
- Campership applications are not registration forms for camp, they are solely applications for financial assistance. You must also complete the appropriate registration form for the camp your Scout is attending.
 - If you are registering for camp online through the council website, select the “pay by check” or “mailing payment” option.
 - If your child is attending camp with their troop, notify your troop leader that you are applying for a campership and follow the sign-up procedures for your troop.
- Campership applications should be submitted to the Marin Council office when you register your Scout for camp. Camperships submitted after May 15th may not be considered.
- Complete the first two pages of the campership application. If you are applying for a campership to a National high adventure base, the Scout’s unit leader will need to complete the last page for consideration to be given.
- Except for extreme hardship, campership will never exceed 50% of camp fees. Partial payment for camp programs should be submitted with your camp registration. You will be notified of your remaining balance after your Scout’s campership application is reviewed.
- Many troops collect additional fees to help underwrite leader’s fees for camp; families will still be responsible for any additional unit fees associated with camp.
- If you are applying for multiple camperships, use a separate form for each Scout / activity.
- Camp sibling discounts and camperships cannot be combined. If you are applying for sibling discount, please submit that specific short-form and not the campership form.
- Install payment plans are available for all week-long camps. Contact the council office for more information.
