

Important Information

For safety reasons, any youth under 13 years old need to be accompanied by an adult partner. Do not just drop the boys off. Youth need to be supervised on the fishing pier.

Bring your own rod. This is pier fishing, so heavy saltwater gear is not necessary. A sturdy freshwater rod and reel will suffice. Bait will be provided. We suggest a small pocket knife for cutting baite

Tackle should include #8 hooks, I/4 oz. round or oval lead sinkers or split shots, medium bobbers, and at least 10 lb test line.

If bottom fishing for rays and sharks, tackle should include 25-35 lb test line with 2/0-4/0 hooks with 2-4 oz. lead weight.

Bait, rigging, and knot instruction will be provided between 10:00–10:30 a.m.

If you plan on working on the belt loop or merit badge, be familiar with the requirements before the event and Boy Scouts should bring a blue card.

Bring plenty of water and a water bottle, a hat, a jacket, chap stick, and sun screen. Be Prepared!

Needle-nose pliars may be handy!

License is required for those over 16 years old. This is *not* a California license-free fishing day.

Pre-registration <u>is required</u> and is due no later than May 31. <u>No, really; no exceptions.</u>

You must be present to claim any prizes.

Open to all Cub Scouts, Boy Scouts, Venturers, their families, and friends.
