



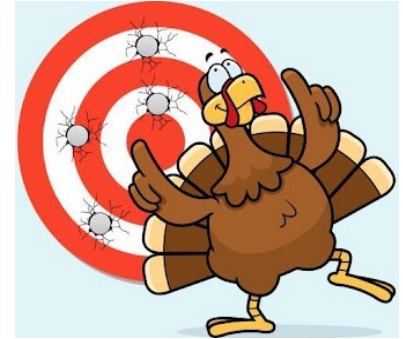

## THANKSGIVING "BIG TURKEY" SHOOT FOR CUB SCOUTS

9am-3:30pm, Saturday, November 19 @ Camp Tamarancho

Presented by your Marin Council Shooting Sports Committee Volunteers!

All Marin Council Cub Scouts are invited to this exciting event to build their marksmanship skills on the Archery and BB-gun ranges. This event is for Cub Scouts only; Tigers through Webelos (*Lions are not permitted to shoot per BSA Policy, and Tigers must have an adult partner with them at all times*).



The cost per participant is only \$10.00 and includes 1 session each of Archery and BB-gun, and a fun participation patch!

***But don't worry, NO turkeys will be shot!***

The registration deadline is November 18, but don't delay because space is limited! ***NO WALK-INS WILL BE ALLOWED!***

A Marin Council Cub Scout Shooting Sports Authorization form must be completed and signed by at least one custodial parent/guardian for each Cub Scout participant in order to shoot – ***no exceptions*** (*see form attached*).

Sessions are 40 minutes long starting at 9:00am and finishing by 3:30pm. All participants must arrive at least 15-20 minutes before their session for a mandatory safety briefing. If they miss this, they will not be allowed to shoot!

Everyone should bring face masks, and no loose clothing or jewelry can be worn while shooting on the range. Everyone must wear closed-toed shoes in camp. No dogs or other pets are allowed (*except service/helper dogs*).
